Thank you for registering for access to Tuesday's Children's Long-Term Healing Model. By registering to access it and clicking "I agree," You are agreeing that You have read and understand this License and that it constitutes a legally binding and enforceable contract between You and Tuesday's Children.

1. **OWNERSHIP AND USE OF THE MODEL**

- (a) You agree and acknowledge that the Long Term Healing Model, including all data, information, questionnaires, forms, curricula, graphics, text and other content, as well as methodologies and ideas, included as part of or embodied therein (collectively, the "Model") is the sole and exclusive intellectual property of Tuesday's Children.
- (b) Tuesday's Children hereby grants You a personal, revocable, non-transferable license solely to access the Model (via Your authorized user name and password assigned specifically to You).
- (c) You agree not to, under any circumstance, sublicense, display, rent, lease, provide access to, transfer, distribute, or otherwise share the Model or any portion of it. 3. INDEMNIFICATION

You agree to indemnify, defend and hold harmless Tuesday's Children, its subsidiaries, affiliates, partners, employees, officers, directors, advisors, licensees, licensors, licensors and content providers ("Tuesday's Children Indemnitees") from and against any and all claims, demands, actions, liabilities, damages, or expenses resulting therefrom, including court costs and reasonable attorney fees, arising out of or related to: (a) any violation by You, Your affiliates or Your and their employees, officers, directors, members, and agents (collectively, "Your Representatives") of the terms and conditions of this License or unauthorized use of the Model by You or Your Representatives; or (b) Your use of the Model.

5. MISCELLANEOUS TERMS

- (a) **Assignability.** To help Tuesday's Children control the dissemination of and protect our rights in the Model, this License cannot be assigned or otherwise transferred by You without the prior written consent of Tuesday's Children. Because Tuesday's Children owns the Model, it has the right to sell or otherwise transfer it and accordingly, You agree that Tuesday's Children can assign this License and its rights hereunder to any acquirer of the Model or successor.
- (b) **Governing Law.** This License is governed by the laws of the State of New York without application of the principles of conflicts of law. You and Tuesday's Children each submits to the exclusive jurisdiction of the State and Federal Courts located in New York City, Borough of Manhattan, for any action or proceeding relating to this License, and expressly waives any objection it may have to such jurisdiction or the convenience of such forum.
- (c) **Construction.** If any provision of this License is held by a court of competent jurisdiction to be invalid or unenforceable, then such provision shall be enforced to the maximum extent permissible so as to affect the intent of this License, and the remainder of this License shall continue in full force and effect.
- (d) **No Waiver.** No delay on our part in exercising any right or remedy under this License shall operate as a waiver thereof, nor shall any waiver on the part of either party, nor any single or partial exercise of any right under this License, preclude any other or further exercise thereof or any other right under this License. Each party's rights and remedies under this License are cumulative and are not exclusive of any rights and remedies provided for by law, in equity or otherwise.
- (e) **Survival.** All provisions in this License regarding representations and warranties, indemnification, disclaimers and limitations on liability shall survive any termination of this License.

- (f) **Headings.** Section headings in these Terms of Use are for convenience of reference only and shall not affect the construction or interpretation of any provision of this License.

6. MODIFICATIONS TO THIS LICENSE: Tuesday's Children may, in its sole discretion and at any time, modify the terms of the License, in whole or in part, by sending you notice of them. Your continued use of the Model following the posting or notice of changes will operate as an acknowledgement of Your acceptance of the then current License.
